## **SUMMARY OF SA SCHOOLS SQUASH RULES**

### **Team order & procedure in the event of illness/injury**

Provinces/Regions MUST play their players in order of strength. The order must be announced BEFORE the start of the IPT at the first managers' meeting and may not change during the IPT.

Players cannot be played lower down an order because they are carrying an injury at the start of IPT.

In the event of either an injury or illness in the A section, a replacement player MUST be brought in from the B section and all the A team players MUST move up one position with the B section player playing at number 5 in the A team.

The B team then plays without a reserve – hence the reason for a 6-man B team. Provinces may NOT send for a replacement player.

If a player does not complete a match/concedes a match, it is accepted that he/she has withdrawn from the team for the remainder of the IPT - unless the injury was inflicted and/or contributed to by an opponent in which case the injured player may return when he/she has recovered.

If these rules are broken (whether through ignorance or not) then that region's A and B teams in that gender will both be disqualified and will lose all the points for the match in which they defaulted AND all subsequent points in the IPT.

The injury rule must be listed on the reverse side of the match card.

The order of play will be (6); 3; 4; 5; 2; 1.

### **Expulsion from IPT**

In the event of a player being sent home for disciplinary reasons, that player MAY NOT be replaced. His/her team will play short for the rest of the IPT. Players will move up the order within the team. There will be no movement from B team to A team.

### **Procedure for every IPT**

All players (the whole team and the manager) MUST be present at the start of a fixture.

No player may leave the courts during the fixture unless he has completed his match and needs to get to medical treatment. A player may not arrive late because he/she is at physio (or any other medical / personal reason).

Only the tournament referee may delay the start of a match for extreme reasons – like a flat tyre or an accident etc). Should the entire team not be present at the start of play (morning and/or afternoon) then the first fixture in the match (the no 3 fixture) will be awarded to the team that is present and after a further 15 minutes the second fixture will be conceded.

Should the team not be present half an hour after the scheduled start, the match will be awarded 20-0 to the team that is present and ready to play.

The offending team will also be penalized three points on the log, but that deduction does not hold for the match. The result of the match will be recorded, and the three-point deduction will be handled by the tournament organizer on the overall log.

The selectors reserve the right to force those players in contention for national rankings to play their individual fixtures even if the match is cancelled.

### **Withdrawal during the course of IPT for personal reasons**

The SA Schools Squash Executive reserves the right to consider each circumstance individually.

Players making themselves available for participation in IPT teams must understand that they need to be available for the full duration of the event.

In highly exceptional circumstances representation may be made to the SA schools Executive by the province concerned no later than 14 days prior to the start of the event for concessions in this regard.

Should a player withdraw in the middle of an IPT for personal reasons (such as selection for a national cricket team or a provincial hockey team etc) then the same rules will apply as those pertaining to a player being sent home.

Should a player(s) withdraw from IPT, all results of that team (both completed and still scheduled) will be declared null and void. The team will complete their schedule without the missing player(s) but all individual results within the team event will stand for national selection.

In the event of a player having to withdraw from IPT due to a personal, unscheduled family crisis (or similar) the decision will rest with the SA Schools executive as to how that team will continue in the IPT.

#### Scoring system

The province that wins every match wins the event regardless of points.

- 1 point awarded per game won; 5 bonus points for a team win
- Provinces tying on points – head-to-head result will count
- Three-way tie - points will decide
- The PAR scoring system (11 points) will be used

#### Discipline

Players are subject to Article 14 of the Rules and Conditions of SA SCHOOLS SQUASH which states: "All players (regardless of age) attending the tournament shall be subject to school discipline and shall be expected to follow high standards of dress and behaviour both on court and off it."

If a school player, while on court, says or does anything that is not strictly within the rules (e.g. emotional outbursts or intentionally dropping of racket), the point shall be awarded against him or her and, for the second offence, the game in progress shall be awarded against him or her. Should this behaviour be repeated, the match shall be awarded to his or her opponent. Please note that this WILL be strictly enforced.

Jewellery that is worn may not be deemed to create any potential safety concerns on court. Players may be requested to remove such jewellery.

#### Procedure following the abuse of alcohol or substance abuse

Any player found to have been drinking or using/abusing substance(s) will immediately be sent home from the IPT and/or SACFS and suspended from ALL squash (schools, senior and schools' league, Top Schools and Jarvis/Kaplan etc) pending a full disciplinary hearing to be conducted by the SA Schools Squash Disputes Committee.

At least one lawyer will serve on this Disputes Committee.

The headmaster of the school which the player(s) attend (or his appointed representative) will be notified.

#### Accommodation

ALL regions are required to stay in the IPT accommodation as organized by the IPT organizer.

#### First Aid Kit

All teams are responsible for their own basic first aid kit. This is not an item in the budgets for IPT.

## **IPT INFORMATION**

### **COVID-19 REGULATIONS**

- Albeit the regulation has been lifted we still advise to practice good behaviour
- Please respect those that still wish to adhere to protocol.
- Spectators are welcome, but please [practice social distancing and avoid crowding.
- We will have sanitising stations at entrances.

### **VENUES**

- We are guests. Please respect the Venue rules; including the hostel

### **IMPORTANT INFORMATION**

- Players must be available for the duration of the IPT
- Players must be ready to play immediately after the previous match
- Reschedules will not be allowed
- No intimidation of players, markers, or referee's during and after play will be tolerated

### **CONDUCT AND BEHAVIOUR**

- The 4-minute warm up and 90-second game break rule will be strictly monitored
- Players must adhere and abide to the SA Schools Squash Rules
- The decision of the tournament referee is final
- Use of WSF approved protective eyewear in every match is compulsory – including during warm up or social games. (No exceptions can be made)
- The players, as indicated by SA Squash and WSF standards, must wear the correct clothing

### **SCORING**

- Every match will be Best of 5, PAR 11
- 1 point per game won will be awarded to each team
- 5 bonus points is awarded to the team that wins the most matches
- The unbeaten team, if any, is declared the winner; thereafter, teams are placed in accordance with points won. If teams finish on equal points the Head-to-Head result determines the placing
- The High-Altitude Ball will be used

### **IPT 80'S EVENING**

- Venue will be CBC Sports Ground, Groenkloof
- No players may leave the venue unless accompanied by a manager
- Dinner will be served at Affies Hostel prior to departure
- Players will receive 2 refreshments vouchers for the evening
- Managers will receive a small cash token per province
- Dry snacks will be served (Crisps / Pretzels / Sweets)
- Player consumption of alcohol or any illicit substance usage is strictly forbidden (SA Schools Rules apply)
- There will be a DJ and requests are permitted
- A photobooth will be available to take snap shots of the experience
- We encourage teams to dress up for the event

#### **4. THE WARM-UP**

4.1. At the start of a match the players go on court together to warm up the ball for a maximum of 4 minutes. After 2 minutes the players must change sides, unless they have already done so.

4.2. The players must have equal opportunities to strike the ball. A player retaining control of the ball for an unreasonable time is warming up unfairly and Rule 15 (Conduct) must be applied.

#### **7. INTERVALS**

7.1. A maximum of 90 seconds is permitted between the end of the warm-up and the start of play, and between each game.

7.2. Players must be ready to resume play at the end of any interval, but play may resume earlier if both agree.

7.3. A maximum of 90 seconds is permitted to change damaged equipment. This includes eye-wear or a dislodged contact lens. The player must complete the change as quickly as possible, or Rule 15 (Conduct) must be applied.

7.4. Intervals in the case of injury or bleeding are specified in Rule 14 (Injury).

7.5. During any interval either player may strike the ball.

#### **8.13. TURNING**

Turning is the action of the player who strikes, or is in a position to strike, the ball to the right of the body after the ball has passed behind it to the left or vice versa, whether the player physically turns or not. If the striker encounters interference while turning, and could have made a good return, then:

- 8.13.1. if the swing was prevented, even though the opponent was making every effort to avoid the interference, a stroke is awarded to the striker.
- 8.13.2. if the non-striker had no time to avoid the interference, a let is allowed.
- 8.13.3. if the striker could have struck the ball without turning but turned in order to create an opportunity to request a let, no let is allowed.
- 8.13.4. When the striker turns, the Referee must always consider whether the action was dangerous and rule accordingly.

#### **9. BALL HITTING A PLAYER**

9.1. If the ball, on its way to the front wall, hits the non-striker or the non-striker's racket or clothing, play must stop; then:

- 9.1.1. if the return would not have been good, the non-striker wins the rally.
- 9.1.2. if the return was going directly to the front wall, and if the striker was making a first attempt without having turned, a stroke is awarded to the striker.
- 9.1.3. if the ball had hit or would have hit any other wall before the front wall and the striker had not turned, a let is allowed, unless the return would have been a winning return, a stroke is awarded to the striker.
- 9.1.4. if the striker had not turned but was making a further attempt, a let is allowed.
- 9.1.5. if the striker had turned, a stroke is awarded to the non-striker, unless the non-striker made a deliberate movement to intercept the ball, in which case, a stroke is awarded to the striker.

#### **13. FALLEN OBJECT**

13.1. A player who drops a racket may pick it up and play on, unless the ball touches the racket, or distraction occurs, or the Referee applies a Conduct Penalty.

13.2. A striker who drops the racket because of interference may request a let.

13.3. A non-striker who drops the racket because of contact during the striker's effort to reach the ball may request a let, and Rule 12 (Distraction) applies.

13.4. If any object, other than a player's racket, falls to the floor during a rally, play must stop; then:

- 13.4.1. if the object fell from a player without any contact with the opponent, the opponent wins the rally.
- 13.4.2. if the object fell from a player because of contact with the opponent, a let is allowed, unless the striker has struck a winning return, or requests a let for interference, in which case Rule 8 (Interference) is applied.
- 13.4.3. if the object falls from a source other than a player, a let is allowed, unless;
- 13.4.4. the striker's winning return was interrupted, in which case the rally is awarded to the striker.
- 13.4.5. if the object was not seen until the rally ended and had no effect on the outcome of the rally, the result of the rally stands.

#### 14. BLOOD RULE

Rule 14.4 Blood Injury updated to read:

**"A Blood Injury is defined as being when bleeding occurs, and the **blood flow is sufficient that blood can be transferred from a player to their opponent or the court.****

A scrape, graze or nick with no blood flow does not constitute a Blood Injury and play must continue. Visible blood through a bandage, dressing or covering is not considered a Blood Injury.

Where there is a stoppage in play, the court must be cleaned, and bloodstained clothing replaced.

Once a Blood Injury occurs, the injured player must leave the court and it is the referee's responsibility to ensure that the injured player returns to the court in the shortest time possible, according to the following rules:

##### 14.4.1 Self-inflicted

Where the Blood Injury is caused by a player's own action or condition, such as a fall, lunge, dive, crowding, nosebleed or similar, the player is permitted 5 minutes to stem the flow of blood and cover the bleeding. The referee is in charge of starting the timer, which will start from when the injured player's treatment begins. If the injured player is not ready to resume play after 5 minutes has elapsed, the player must concede the game and take the game interval, if available, for further recovery.

If the same Blood Injury reoccurs, no further recovery time is permitted, and the injured player must concede the game and take the next game interval, if available, for further recovery. If the injured player cannot resume play within the permitted time allowed, the referee will award the match to the injured player's opponent.

##### 14.4.2. Contributed

Where the Blood Injury is caused by both players' actions, the injured player has reasonable time to stem the flow of blood and cover the bleeding. Reasonable time is determined by the referee, who can be assisted by the on-site medical personnel, if available.

If the same Blood Injury reoccurs, through no fault of either player or by both players' actions, the injured player shall have further reasonable time to address the Blood Injury.

If the same Blood Injury reoccurs, due to an action solely by the injured player, the player shall have no further time to address the Blood Injury and must concede the game and take the game interval, if available, for further recovery.

If the injured player cannot resume play within the reasonable time or extended periods allowed, the referee will award the match to the injured player's opponent.

##### 14.4.3. Opponent inflicted

Where the Blood Injury is caused solely by the opponent:

14.4.3.1. Where the Blood Injury is solely caused by the opponent's accidental action, the injured player has reasonable time to stem the flow of blood and cover the bleeding. Reasonable time is determined by the referee, who can be assisted by the on-site medical personnel, if available. If the injured player cannot resume play in the reasonable time allowed, the referee will award the match to the injured player.

If the same Blood Injury reoccurs, through no fault of either player or by both players' actions, the injured player

shall have further reasonable time to address the Blood Injury. If the blood flow cannot be stopped in a reasonable time the referee will award the match to the injured player.

If the same Blood Injury reoccurs, due to an action solely by the injured player, the player shall have no further time to address the Blood Injury and must concede the game and take the game interval, if available, for further recovery. If the injured player cannot then resume play within the reasonable time or extended periods allowed, the referee will award the match to the injured player's opponent.

14.4.3.2. Where the Blood Injury is caused by the opponent's deliberate dangerous play, Rule 15: Conduct must be applied, and the referee will award the match to the injured player.

## **15. CONDUCT**

15.1. Players must comply with any tournament regulations additional to these Rules.

15.2. Players may not place any object within the court.

15.3. Players may not leave the court during a game without the permission of the Referee.

15.4. Players may not request a change of any Official.

15.5. Players must not behave in a manner that is unfair, dangerous, abusive, offensive, or in any way detrimental to the sport.

15.6. If a player's conduct is unacceptable, the Referee must penalise the player, stopping play if necessary. Unacceptable behaviour includes, but is not limited to:

- 15.6.1. audible or visible obscenity;
- 15.6.2. verbal, physical or any other form of abuse;
- 15.6.3. unnecessary physical contact, includes pushing off the opponent;
- 15.6.4. dangerous play, including an excessive racket swing;
- 15.6.5. dissent to an Official; 15.6.6. abuse of equipment or court;
- 15.6.7. unfair warm-up;
- 15.6.8. delaying play, including being late back on court;
- 15.6.9. deliberate distraction;
- 15.6.10. receiving coaching during play.

15.7. A player guilty of an offence may be given a Conduct Warning or penalised with a Conduct Stroke, a Conduct Game, or a Conduct Match, depending on the severity of the offence.

15.8. The Referee may impose more than one warning, stroke or game to a player for a subsequent similar offence, providing any such penalty may not be less severe than the previous penalty for the same offence.

15.9. A warning or a penalty may be imposed by the Referee at any time, including during the warm-up and following the conclusion of the match.

15.10. If the Referee:

- 15.10.1. stops play to issue a Conduct Warning, a let is allowed;
- 15.10.2. stops play to award a Conduct Stroke, that Conduct Stroke becomes the result of the rally;
- 15.10.3. awards a Conduct Stroke after a rally has finished, the result of the rally stands, and the Conduct Stroke is added to the score with no change of service-box;
- 15.10.4. awards a Conduct Game, that game is the one in progress or the next one if a game is not in progress. In the latter case an additional interval of 90 seconds does not apply;
- 15.10.5. awards a Conduct Game or a Conduct Match, the offending player retains all points or games already won;

15.11. When a Conduct Penalty has been imposed, the Referee must complete any required documentation.
